Majority of HIV infections

- >sexually transmitted, or
- >associated with pregnancy, childbirth & breastfeeding

Linking SRH & HIV **Common root causes**

- Poverty
- Gender inequality
- Gender-based violence
- > Human rights violations
- Marginalization of vulnerable populations
- > Stigma and discrimination

Linking SRH & HIV Benefits of Linking 1/2

- Improved access to and uptake of key HIV and SRH services
- better access of PLHIV to SRH services tailored to their needs
- reduction in HIV-related stigma and discrimination
- improved coverage of underserved / vulnerable / key populations
- greater support for dual protection against unintended pregnancy and STI including HIV
- improved quality of care



Linking SRH & HIV Benefits of Linking 2/2

- decreased duplication of efforts and competition for scarce resources
- better understanding and protection of individuals' rights
- mutually reinforcing complementarities in legal and policy frameworks
- enhanced programme effectiveness and efficiency
- better utilization of scarce human resources for health


Linking SRH & HIV: Services of Swiss Family Planning centers


- Legal basis: Federal law of 1981: information and counselling in the context of pregnancy, prevention of unintended pregnancies
- Code of practice with guidelines for counselling: Consistent linkage of SRH/HIV: Dual protection Prevention and promotion of sexual health
- New federal law on prevention and health promotion? New legal basis to anchor both SRH and HIV

Linking SRH & HIV: HIV testing: Case study Valais Family planning centers offering rapid HIV testing and counselling: Easy access Several centers already established in the canton Larger target group: "general public" HIV embedded in broader SRH context





Linking SRH & HIV Conclusions

 How far the linkage can go depends on the context
- Overall positive effects of linkage
 Services embedded in broader context of sexual and reproductive health & rights
